Immediate Disaster Assistance:

If you need disaster assistance immediately, contact FEMA at <u>1-800-621-3362</u>. You can start the disaster assistance application process by either (1) registering online at **www.DisasterAssistance.gov** (2) through a web-enabled mobile device or smartphone by visiting **http://m.fema.gov/** and following the link to "apply online for federal assistance" or (3) by calling 1-800-621-FEMA (3362).

Internal Revenue Services (IRS): The IRS has issued a series of news releases on tax relief for Hurricane Sandy victims in New York, New Jersey and Connecticut. See http://readynj.posterous.com/. The IRS provides tax counseling and assistance to taxpayers whose property has been damaged or lost in a federally declared disaster area. Taxpayers also have the option to deduct non-reimbursed casualty losses that occurred in a federally declared disaster area in the year the disaster occurred or file an amended return and deduct the loss in the year immediately preceding the year the disaster occurred. Replacement Food Purchased with Food Stamps. If you've purchased food with food stamps that has spoiled due to flooding/power outage go to your local Women, Infant and Children (WIC) clinic. Most of the 35 sites are open. Check here to see which clinics are open at this time: http://www.nj.gov/health/fhs/wic/documents/office_status.pdf

Unemployment Assistance (DUA): If you are unemployed because of the disaster that began on Oct. 28, you should FIRST file for unemployment insurance benefits through the Internet by going to www.njuifile.net.. The Internet processes claims faster. However, if needed, people may also file a claim by telephone by contacting the state Department of Labor's Re-employment Call Centers at: North Jersey (201) 601-4100, Central Jersey (732) 761-2020, South Jersey (856) 507-2340. A 30-day deadline ending Monday, Dec. 3, 2012 is in effect for filing DUA claims resulting from Hurricane Sandy.

Business Recovery Assistance: For Information on New Jersey's Business Assistance Services call the Business Action Center at 1-866-534-7789.

Pets: If you or someone you know has been separated from their pet or had to leave their pets behind when evacuating their homes due to the storm, the phone number to call is 1-855-407-4787 (1-855-407-HSUS).

Price Gouging: If you have noticed that the price of goods has gone up as a result of the storm, call to report it at (862) 209-0130 or (973) 220-3474.

Helpline for emotional distress: If you or someone you know is feeling grief-stricken by the challenges Hurricane Sandy has presented you, visit www.griefspeaks.com to find a New Jersey counselor who can help you deal with loss.

Waiver of Bank Fees: The following banks have agreed to waive late fees, overdraft fees, etc. due to the Hurricane. Each bank offers a slightly different deal, so make sure to call your bank to find out what fees they are waiving and until when. The list of banks that are waiving fees are: Citibank, Capital One, Chase, Wells Fargo and TD Bank.
