Community Association Group Member Stacey Patterson Discusses New Ways Employees, Managers and Boards Can Get Associations into Legal Hot Water, and How to Avoid Exposure.

TARRYTOWN, NY – What are the necessary tools that homeowner associations, condominium, and co-op boards, along with their management teams can use to increase oversight of their businesses in the current overly litigious environment? This question and related concepts will be discussed by Attorney Stacey R.
